- people staying at hotels/accommodation facilities as a result of measures taken by public authorities, to deal with situations of a social as well as emergency nature resulting from disasters or extraordinary events or for humanitarian relief purposes; (Article 4, paragraph 1, letter d of the Municipal Residence Tax Regulation, C.C. Resolution 46/2021);
- Non self-sufficient disabled people whose conditions are certified in accordance with current regional and/or national legislation of the country of origin and a carer if required; (Article 4, paragraph 1, letter e of the Municipal Residence Tax Regulations, C.C. Resolution 46/2021).
