TOURIST TAX – DATA COLLECTION POLICY

Data Collection Policy pursuant to art. 13 EU Regulation 2016/679 (General Data Protection Regulation)

We inform you that the data collected will be processed in accordance with current legislation on the protection of personal data.

The processing of personal data is carried out for the purpose of compliance with legal obligations connected with the payment of tourist tax pursuant to art. 6 par. 1 letter c) and EU Regulation 679/2016.

Your data will be processed by private and public entities for activities instrumental to the purposes indicated, which the entity will use as data processors: among these categories of subjects there are those who offer hospitality and who act as accounting agents.

Your data will also be communicated to public entities for compliance with legal obligations, always in compliance with current legislation on the protection of personal data.

Your data will not be transferred to another country.

We inform you that the provision of data is mandatory. Should you not provide this information, or refuse to pay the tourist tax, the municipal administration reserves the right to operate as it sees fit to recover the tax and to apply the penalties established by the current regulation.

The data will be kept for the time necessary to pursue the purposes indicated and in compliance with the related legal obligations.

The interested party may, at any time and where possible, assert his/her rights, in particular with reference to the right to access his/her personal data, as well as the right to obtain the correction or limitation, updating and deletion, as well as with reference to the right of data portability and the right to object to the processing, unless there is a legitimate reason of the Data Controller to prevail over the interests of the data subject, or to ascertain, exercise or defend a right in judicial seat.

The interested party may exercise his/her rights by contacting the Data Controller or Data Protection Officer, who can be contacted at the contacts indicated above.

The interested party has the right to lodge a complaint with the Data Protection Authority if he/she deems it necessary.

The Data Controller does not adopt any automated decision-making process, including profiling, as per article 22, paragraphs 1 and 4, of EU Regulation no. 679/2016.
